I am pleased to be informing you, on behalf of the Board of Directors of APS Bank plc, of the extraordinary general meeting (referred to below as 'EGM') to be held on 19 October 2022 at 11:00 a.m. In our Company Announcement dated 28 July 2022, the Bank declared an interim dividend through the issue of new shares.
